Thomas Borncamp has been lead and co-lead trial counsel in numerous products liability and other complex cases. Mr. Borncamp has not only defended helmet and protective mask manufacturers in concussion and catastrophic brain injury litigation, he has been a speaker on the topic for the Federation of Defense and Corporate Counsel and the Association of Corporate Counsel. He has successfully defended vehicle, tire, sporting goods, safety equipment, head protection, fire protection, respiratory protection and other product manufacturers and Fortune 500 Companies in high-exposure, complex lawsuits and class actions across the United States. He also defended hotel and apartment complexes in premises liability and other negligence cases, defended and advised companies in Proposition 65 matters, and represented clients in contractual disputes. Mr. Borncamp has also been a presenter on trial practice, discovery, document retention policies and witness preparation for numerous corporate clients. His practice also involves managing national and regional litigation and providing specialized guidance regarding discovery to U.S. and foreign corporate defendants.

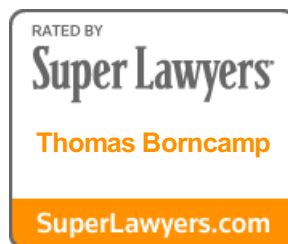
